

AGREEMENT FOR CONTRACT SERVICES

THIS AGREEMENT, made this 2nd day of October, 2009, by and between the Village of La Grange, hereinafter called the OWNER, and United Septic, Inc. doing business as a Corporation (*), hereinafter called the CONTRACTOR.

(* SPECIFY: "individual", "partnership", or "corporation")

WITNESSETH, that for and in consideration of the payments and agreements hereinafter mentioned:

1. The CONTRACTOR accepts the responsibility to complete in accordance with the Contract Documents the construction of the:

2009 TELEVISED SEWER INSPECTION SURVEY

2. The CONTRACTOR will furnish all of the materials, supplies, tools, equipment, labor and other services necessary for the construction and completion of the PROJECT described herein.
3. The CONTRACTOR will commence the work required by the REQUEST FOR PROPOSAL within 10 calendar days after the date of the NOTICE TO PROCEED and will complete the same within 60 calendar days unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS.
4. The CONTRACTOR agrees to perform all of the WORK described in the REQUEST FOR PROPOSAL and comply with the terms therein for the sum of \$35,495.40, or as shown in the BID schedule.
5. The term "CONTRACT DOCUMENTS" means and includes the following:
 - (A) NOTICE TO BIDDERS
 - (B) INFORMATION FOR BIDDERS
 - (C) BID PROPOSAL
 - (D) SPECIAL PROVISIONS
 - (E) SPECIFICATIONS
 - (F) CONTRACT PAY ITEMS
 - (G) DRAWINGS
 - (H) NOTICE OF AWARD
 - (I) AGREEMENT FOR CONTRACT SERVICES
 - (J) NOTICE TO PROCEED
 - (K) CHANGE ORDERS






