**Cook County Issues 2010 Reassessment Notices/Appeals Process Open Until October 25, 2010** — Properties in Lyons Township were reassessed by the Cook County Assessor in 2008. Notices concerning the reassessment of properties in Lyons Township were recently mailed out by Cook County.

There are two ways to file an appeal of your reassessment. First, you may file an appeal on-line with the Cook County Assessor's office at [www.cookcountyassessor.com](http://www.cookcountyassessor.com). Second, you can file an appeal through the Lyons Township Assessor's office. The office of the Lyons Township Assessor is located at 5540 East Avenue, Countryside, IL 60525. In person visits are welcome.

The final date for filing an appeal through Lyons Township is October 25, 2010 at 12:00 noon. Office hours are Monday through Friday, 8:30 a.m. — 4:30 p.m.
