VILLAGE OF LA GRANGE Finance Department PARKING DECAL POLICIES -COMMUTERS-

The Village of LaGrange has designated several lots and "on street" parking areas as "Decal Parking Only" for both resident and non-resident Metra commuters. Parking areas or "zones" are located along Hillgrove Avenue between La Grange and Willow Springs Roads. In addition, two commuter parking lots are located at Burlington and 7th (Lot 12) and Burlington and Brainard (Lot 13). Individuals may park in these areas provided they purchase and **display** a current decal.

Decals can be purchased through "How Do I" tab on the left hand side of the Village's home page at: www.villageoflagrange.com. Decals are processed online, in real time. Once a parking decal is issued, there will be NO REFUNDS. Direct any questions to the Finance Department at (708) 579-2300. Business hours are Monday through Friday, 8:30 a.m. to 5:00 p.m.

PER VILLAGE ORDINANCE, DECALS MUST BE DISPLAYED IN THE LOWER PORTION OF THE MAIN REAR WINDOW, PASSENGER SIDE.

- 1. <u>Decal prices vary according to location</u>. Any decal not yet issued is subject to price change without notice.
- 2. Commuter decals are sold for specific areas or lots; however no particular space is assigned in that lot. The decal allows the individual to park from 6:00 a.m. to 6:00 p.m. Evening hours from 6:00 p.m. to 2:00 a.m. are considered free parking (no decal required), as are weekend daytime hours in all decal lots.
- 3. Commuter decals must be purchased in <u>increments of 3, 6 and 12 months (quarterly, semi-annually)</u>.
- 4. <u>LOT #2 and 12 RESIDENT APPLICANTS: A photocopy of a current document</u> (utility bill, property tax bill, lease agreement, vehicle license, etc.), <u>MUST accompany EACH application to verify residency.</u>
- 5. <u>LOT #13 APPLICANTS: A photocopy of your most current train pass MUST accompany EACH application.</u> This lot is owned by the railroad and is provided for commuters. Local high school students are not allowed to purchase space in this lot.
- 6. In order to accommodate multi-car families or car pools where more than one car might be used, applicants are invited to describe both cars online. The decal must be displayed in the window of the car being used that day. If you forget to display the decal, you will be responsible for any parking tickets issued.
- 7. If you have dark tinted rear windows, please display the decal on the windshield, passenger side, near the top.

- 8. If you find that your decal area is full, you will be allowed to park in a timed zone space (such as 2-hour or 3-hour) nearest to your decal area. You should then call the Police Dept. Parking Enforcement Division at 708/579-2309 to report the situation. Please do not park in any other decal lot or local business's lots. If you choose to park at a meter, you must pay the meter for that day.
- 9. Individuals violating these rules are subject to fines and responsible for same. Vehicles may also be towed from the space at the vehicle owner's expense. Any abuse of parking privileges will result in revocation of the parking decal.
